Funding Accelerated provides a managed technical assistance service in which we trade on prop firm evaluation accounts that you have purchased in your own name. We attempt to pass the evaluation phases so that the prop firm may issue a funded account to you. This is not an investment product. This is not financial advice. This is a high-risk, speculative service with a high probability of total loss of the fees you pay.

You confirm that you fully understand the service being offered and that you are not relying on any statement, promise, or implication of success, profit, or funding that is not expressly set out in our written Terms of Service.

2. GENERAL TRADING RISK WARNING

Trading foreign exchange (forex), CFDs, commodities, indices, cryptocurrencies, and other leveraged instruments involves a substantial risk of loss and is not suitable for all persons. The high degree of leverage can work against you as well as for you. You can lose more than your initial capital in some cases. You should carefully consider your investment objectives, experience level, and risk appetite before engaging in any trading activity. Past performance is not indicative of future results.

3. PROP FIRM EVALUATION & FUNDED ACCOUNT RISKS (CRITICAL)

You expressly acknowledge, understand, and accept the following risks that are inherent in prop firm evaluations and in using our managed service:

- **Prop Firm Absolute Discretion:** Prop firms have complete discretion to approve, reject, reverse, suspend, terminate, or ban evaluation and funded accounts for any reason or no reason, including suspected third-party trading, rule breaches, KYC/AML issues, platform changes, or policy changes. We have zero control over prop firm decisions.
- **Third-Party / Managed Trading Detection Risk:** Many prop firms expressly prohibit or heavily restrict the use of third-party traders, account managers, copy trading, or automated systems. Even if we follow published risk parameters, there is a real and material risk that the prop firm will detect or suspect external management and immediately terminate the account, ban you permanently, and forfeit all fees and any potential profits with no recourse. You accept this risk completely.
- **Rule Changes Mid-Challenge:** Prop firms frequently change their rules, risk parameters, profit targets, and terms with little or no notice. Such changes may render our strategy ineffective or cause failure through no fault of ours.
- **Loss of All Challenge Fees:** Fees you pay directly to prop firms are almost always non-refundable. If the challenge fails or the account is terminated, those fees are lost forever. We have no liability for any prop firm fees.
- **No Control Over Prop Firm Infrastructure:** We have no control over the prop firm's trading platform, servers, execution quality, spreads, slippage, latency, downtime, or payout processes. Platform issues can cause losses or failed challenges.
- **Payout & Profit Risk:** Even if a funded account is obtained, there is no guarantee of consistent profits, successful withdrawals, or that the prop firm will honor profit-sharing or payout requests. Many funded traders never receive meaningful payouts.
- **Account Rejection After Funding:** Prop firms sometimes reverse or cancel funded accounts after issuance (for example after KYC review or rule audits). You bear 100% of this risk.
